

# FEES AND PAYMENT PLAN

All students who enroll into Contempo College agree to pay the following fees and we offer a payment plan.

## FEES

As a Nationally Registered Training Organisation we are able to collect fees from the student and must provide or direct the student to information specifying:

- Fees that must be paid to us;
- · Payment terms and conditions including deposits and refunds;
- Student's rights as a consumer, including but not limited to any statutory cooling-off period;
- Student's right to obtain a refund for services not provided by us in the event the:

Any late fees will be charged a 5% surcharge on the outstanding amount to be charge if the payment is not paid in accordance to the documented time plan.

Reduced fee for transitioning students from another RTO who have already completed some Units of Competency.

Payment 5 – paid at the commencement of Fifth Semester

- Equivalent to 1/8 of the course cost;
- Any late payment penalty (if applicable);

Payment 6 - paid at the commencement of the Sixth Semester

- Equivalent to 1/8 of the course cost;
- Any late payment penalty (if applicable);

Payment 7 - paid at the commencement of Seventh Semester

- Equivalent to 1/8 of the course cost;
- Any late payment penalty (if applicable);

Payment 8 - paid at the commencement of Eighth Semester

- Remainder of fee;
- Any late payment penalty (if applicable).
